

RULES PURSUANT TO ART. 11 OF PRESIDENTIAL DECREE NO. 430 OF 26 2001
PRIZE CONTEST
"FANTAGIRO D'ITALIA 2025"
(CL 95/2025)

PROMOTER

The contest is organized by RCS Sport S.p.A., with its registered office at Via Rizzoli 8 – 20132 Milan, Italy (hereinafter referred to as the "Promoter").

DELEGATED COMPANY

Clipper S.r.l., located at Via Caterina da Forlì 32 – 20126 Milan, Italy (hereinafter referred to as the "Delegate").

CONTEST AREA

The contest is conducted through the official website www.fantagiroditalia.it (hereinafter referred to as the "**Website**"). Participant data collected for the draw will be stored on servers located in Italy. The contest management server operates in a cloud environment, and participant data will be mirrored on a designated server in Italy. The prize draw will consider only data registered on the Italian server. The Promoter commits to providing public authorities with the contest database upon request, including requests made through the Delegate. The Promoter does not operate as an **Internet Service Provider** and does not derive financial gain from participant internet connections. Connection costs are subject to the participant's personal internet service plan.

DURATION

The contest will run from 26 March 2025, until 11:59:59 PM on 31 May 2025.

Prize draws will take place by 15 April 2025 (first draw) and 16 June 2025 (second draw), as specified below.

ELIGIBILITY

The contest is open to all end-users aged 18 or older at the time of participation (hereinafter referred to as "Participants"). Excluded from participation are employees and collaborators of the Promoter, employees of companies involved in organizing the contest, and anyone who does not meet the definition of a Participant.

PUBLICITY

The contest will be promoted on the Website, where the full set of rules will be made available. The Promoter reserves the right to use additional advertising channels, in compliance with Presidential Decree no. 430/2001 regarding prize contests. Advertising related to the contest will remain consistent with these rules.

PARTICIPATION PROCEDURE

The Promoter organizes the Contest, which will take place as described below and will allow all Participants to take part in the scheduled draws, subject to registration and, where required, the selection of a team consisting of 8 cyclists and the appointment of a captain within the designated section of the website, as specified below. In particular, during the contest period, in order to participate in the scheduled draw, Participants will first be required to access the Website to complete the registration process free of charge. Connection costs to the Website depend on the Participant's personal internet service plan. Access to the

Website may also occur through redirection from advertising banners leading Participants to the registration form. All Participants will be required to complete the registration form by providing all mandatory personal details. Each Participant may register only once for the purposes of the Contest, and the Promoter reserves the right to verify compliance with this rule. If multiple entries from the same Participant are detected, they will be disqualified and excluded from the draw. Each email address may be associated with only one Participant, and each Participant may register using only one email address. No participation under a false name, false identity, or fictitious identity will be allowed, nor will duplicate registrations be accepted. The Promoter reserves the right to request a copy of an identity document at any time to verify the accuracy of the personal details provided and the identity of the Participants, taking any necessary action in case of rule violations.

This procedure must be carried out according to the following schedule in order to participate in the scheduled draws:

- registration from 26/03/2025 to 11/04/2025 at 23:59:59 to participate in the first draw, reserved for residents or domiciled individuals in Italy (scheduled by 15/04/2025);
- registration and selection of a team of 8 cyclists and appointment of a captain from 26/03/2025 to 31/05/2025 at 23:59:59 to participate in the second draw (scheduled by 16/06/2025).

Participation in the draw(s) will not occur automatically but will always require the Participant's registration and, where required, the selection of a team. Therefore, failure to register and, where required, to select a team within the specified deadlines will prevent the Participant from taking part in the draw(s).

DRAW PROCEDURE & PRIZES

The 1st draw will take place by 15/04/2025 in Milan, at the office of the Delegate or another agreed location, in the presence of a Notary or an Official of the local Chamber of Commerce, where the scheduled intermediate draw will be conducted. The Promoter will provide a file containing valid registrations from 26/03/2025 to 11/04/2025 at 23:59:59, and the following will be drawn: 47 winners and 47 reserves, with one reserve assigned for each winner to replace them in case of unavailability and/or non-compliance by the initially drawn winners.

The 2nd draw will take place by 16/06/2025 in Milan, at the office of the Delegate or another agreed location, in the presence of a Notary or an Official of the local Chamber of Commerce, where the scheduled final draw will be conducted.
